***Section 72 of the Charities Act 1993 disqualifies people who are:**

Subject to the following provisions of this section, a person shall be disqualified for being a Charity Trustee or Trustee for a Charity if -

(a) have been convicted of any offence involving dishonesty or deception;

(b) have been adjudged bankrupt or sequestration of his estate has been awarded and (in either case) he has not been discharged;

(c) have made a composition or arrangement with, or granted a trust deed for, his creditors and has not been discharged in respect of it;

(d) have been removed from the office of Charity Trustee or Trustee for a Charity by an order made by the Commissioners or by the high court on the grounds of any misconduct or mismanagement in the administration of the Charity for which he was responsible or to which he was privy, or which he by his conduct contributed to or facilitated;

(e) have been removed, under section 7 of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 (powers of Court of Session to deal with management of charities), from being concerned in the management or control of any body;

(f) are subject to a disqualification order under the [1986 c. 46.] Company Directors Disqualification Act 1986 or to an order made under section 429(2)(b) of the [1986 c. 45.] Insolvency Act 1986 (failure to pay under County Court administration order).
